





HIGHLIGHTS

- The COVID-19 vaccination campaign started in March, 2021 in accordance with the National Plan for the Introduction of Vaccination against COVID-19 (PNIV) published in the Official Bulletin No. 19, February 18, 2021;
- As of the 15th of August, approximately 199 745 (53.9%) people belonging to the target population were vaccinated with the first dose and 38 276 (10.3%) people were vaccinated with the second dose;
- By the 15th of August, 50.6% (125 221) of the general eligible population (≥ 18 years of age who do not belong to the risk groups defined in the PNIV against COVID-19) had been vaccinated with the first dose;
- As of 15th of August, the country had administered 238 021 (58.2%) doses of the vaccines received, through the COVAX mechanism and donations from partner countries;
- The waiting period for people who had been infected with COVID-19 to get vaccinated was reduced from 6 to 3 months;
- Government published Resolution 78/2021 and Rectification 127/2021 of July 30, which approves the CABO VERDE COVID CERTIFICATE as a document proving the low risk of its holder being an active COVID-19 patient...; https://covid19.cv/wp-content/uploads/2021/07/bo_30-07-2021_75.pdf




According to data, as of the 15th of August, the municipality of Paul of Santo Antão registered the highest vaccination rate with the first dose, in relation to the eligible population (90,6%).

As of 15th of August, 199 745people were vaccinated with the first dose, 19 661 more people than in the previous week.

Actions carried out

- Publication of the National Plan for the Introduction of Vaccination against COVID-19 https://covid19.cv/wp-content/uploads/2021/02/bo 18-02-2021 19-ok.pdf
- Official publication of the establishment of the National Committee for the management of adverse events following immunization (AEFI).

- Follow-up of AEFI cases by a multi-sectoral team (which includes the National Health Directorate, Integrated Surveillance and Response Service, WHO, UNICEF, Independent Health Regulatory Authority, Office of Pharmaceutical Affairs of the MoH) and the instruments for investigation of AEFI cases;
- Approval of the COVID-19 Certificate, as a document proving the low risk of its holder being an active COVID-19 patient and as a measure to facilitate free movement and the carrying out of activities in the context of the COVID-19 pandemic. Approval of issuance, verification, and acceptance of COVID Certificates from Cabo Verde and recognition of COVID Certificates issued by other countries or multilateral institutions.

According to data, as of the 15th of August, the municipality of Ribeira Brava of São Nicolau Island registered the highest vaccination rate with the two doses, in relation to the eligible population (20.8%).

By the 15th of August, 38 276people were vaccinated with the two doses, 12088 more people than in the previous week.

As of the 15th of August, Cabo Verde had administered 238 021 doses (58.2%) of the available vaccines.

The quantity of vaccines available in the country is sufficient to vaccinate approximately 204 535 people, which corresponds to 55.2% of the estimated target population according to the PNIV.

From the 28th of June to the 15th of August, **66 618** young people aged between 18 and 39 years had received the 1st dose of the vaccine against COVID-19, which represents 29.2% of the estimated population of this age group for this year.
