HIGHLIGHTS

- The COVID-19 vaccination campaign started in March, 2021 in accordance with the National Plan for the Introduction of Vaccination against COVID-19 published in the Official Bulletin No. 19, February 18, 202
- As of the 05th of September, approximately 264 754 (**71.5%**) people belonging to the target population were vaccinated with the first dose and 80 910 (**21.8%**) people were vaccinated with the second dose;
- By the 05th of September, 76.1% (188 421) of the general eligible population (≥ 18 years of age who do not belong to the risk groups defined in the PNIV against COVID-19) had been vaccinated with the first dose;
- As of 05th of September, the country had administered 345 664 (61.8%) doses of the vaccines received through the COVAX mechanism and donations from partner countries;
- On the 03rd of September, the country received a donation of 150 000 doses of the AstraZeneca vaccine from the Republic of Slovenia.
- On September 13, the country received a donation of 56,000 doses of AstraZeneca from Luxembourg.
- The waiting period for people who had been infected with COVID-19 to get vaccinated was reduced from 6 to 3 months, in accordance with directives released on the 19th of July, 2021;
- Government published Resolution No. 82/2021, which approved the requirement to present
 a valid negative RT-PCR or antigen test result, every fourteen days, or a COVID Vaccination
 Certificate, by public and private service providers that provide customer services or who
 have direct contact with the public, as well as those who share common spaces and means
 of transport with them, as a public health protection measure and to reinforce vaccination
 efforts, in view of the COVID-19 pandemic.




According to data, as of the 12th of September, 100% of the eligible population for vaccination of the municipalities of Paul, Ribeira Grande and Tarrafal of São Nicolau had been vaccinated with the first dose.

As of the 12th of September, 273 140 people were vaccinated with the first dose, 8 386 more than in the previous week.

Actions carried out

- Official publication of the establishment of the National Committee for the management of adverse events following immunization (AEFI). (https://www.incv.cv/images/legislacao/Resolucao-n-38 2021.pdf)
- Publication of Resolution No. 82/2021, which approved the requirement to present a valid negative RT-PCR or antigen test result, every fourteen days, or a COVID Vaccination Certificate, by public and private service providers that provide customer services or who have direct contact with the public, as well as those who share common spaces and means of transport with them, as a public health protection measure and to reinforce vaccination efforts, in view of the COVID-19 pandemic. <u>https://covid19.cv/wpcontent/uploads/2021/08/bo_23-08-2021_81.pdf</u>
- Approval of the COVID-19 Certificate, as a document proving the low risk of its holder being an active COVID-19 patient and as a measure to facilitate free movement and the carrying out of activities in the context of the COVID-19 pandemic. Approval of issuance, verification, and acceptance of COVID Certificates from Cabo Verde and recognition of COVID Certificates issued by other countries or multilateral institutions. <u>https://covid19.cv/wp-content/uploads/2021/07/bo_30-07-2021_75.pdf</u>

- Weekly Government-level crisis cabinet meetings involving all government departments with responsibility for immunization and pandemic crisis management.

 Meetings between the risk communication team (INSP) with the health police stations in the northern region of the island of Santiago (Tarrafal, Santa Catarina São Miguel and Santa Cruz, São Salvador do Mundo), where the vaccination rate is even lower to understand the challenges and discuss solutions that involve raising awareness.

- Publication of the Vaccination Bulletin weekly on the Covid19 website https://covid19.cv/boletim-de-vacinacao/

- Presentation of vaccination data at the weekly press conference (every Monday) through the media (TV and radio).

- Biweekly virtual meeting on the status of vaccination led by the National Director of Health with national and international partners (World Bank, WHO, UNICEF, United Nations).

According to data, as of the 12th of September, the municipality of Tarrafal in São Nicolau registered the highest vaccination rate with the two doses. By the 12th of September, **52.5%** of the eligible population had been vaccinated.

By the 05th of September, 95 337 people were vaccinated with the two doses, 14 427 more people than in the previous week.

As of the 12th of September, Cabo Verde had administered 368 477 doses (65.9%) of the available vaccines.

The quantity of vaccines available in the country is sufficient to vaccinate approximately 279 525 people.

From the 28th of June to the 12th of September, 100 454 young people aged between 18 and 39 years had received the one (1) dose of the vaccine against COVID-19, this represents 46.1% of the estimated population in this age group for the current year, (data from Census 2010 by INE).

- Keep the vaccination card that serves as proof of vaccination against the COVID-19.

News: Cape Verde received 56,000 doses of vaccine from Luxembourg



This is a donation that arrived in the country on Monday 13, aboard a flight of the French Air Force military aircraft, which also supported the transport of this donation. There are 56,000 doses of Astrazeneca vaccine and 56,000 syringes that arrived at Nelson Mandela airport.

The arrival of these vaccines was assisted by the Prime Minister of Cape Verde, Ulisses Correia e Silva, the Minister of Health, Arlindo do Rosário and the Minister of Foreign Affairs, Cooperation and Regional Integration, Rui Figueiredo Soares and the Ambassador of Luxembourg, Conrad Bruchentre.
