HIGHLIGHTS

- The COVID-19 vaccination campaign started in March, 2021 in accordance with the National Plan for the Introduction of Vaccination against COVID-19 published in the Official Bulletin No. 19, February 18, 2021;
- As of October 24, approximately 296 723 (80,1% of the target population) were vaccinated with the first dose of the vaccine against Covid-19 and 202 954 (54,8%) of the people were vaccinated with the second dose;
- By the 24th of October, 88.6% (247 490) of the general eligible population (≥ 18 years of age who do not belong to the risk groups defined in the PNIV against COVID-19) had been vaccinated with the first dose;
- As of the 24th of October, the country had administered 499 677 doses (69.9%) of the vaccines received through the COVAX mechanism and donations from partner countries;
- Government published Resolution No. 82/2021, which approved the requirement to present a valid negative RT-PCR or antigen test result, every fourteen days, or a COVID Vaccination Certificate, by public and private service providers that provide customer services or who have direct contact with the public, as well as those who share common spaces and means of transport with them, as a public health protection measure and to reinforce vaccination efforts, in view of the COVID-19 pandemic. https://covid19.cv/wp-content/uploads/2021/08/bo_23-08-2021_81.pdf



According to data, as of the 24th of October, 100% of the eligible population for vaccination of the municipalities of Paul and Tarrafal of São Nicolau and Ribeira Grande in Santo Antão had been vaccinated with the first dose.

As of the 24th of October, 296 723 (80,1%) people were vaccinated with the first dose, 1 927 more than in the previous week.

- Publication of Resolution No. 82/2021, which approved the requirement to present a valid negative RT-PCR or antigen test result, every fourteen days, or a COVID Vaccination Certificate, by public and private service providers that provide customer services or who have direct contact with the public, as well as those who share common spaces and means of transport with them, as a public health protection measure and to reinforce vaccination efforts, in view of the COVID-19 pandemic. <u>https://covid19.cv/wpcontent/uploads/2021/08/bo_23-08-2021_81.pdf</u>
- Approval of the COVID-19 Certificate, as a document proving the low risk of its holder being an active COVID-19 patient and as a measure to facilitate free movement and the carrying out of activities in the context of the COVID-19 pandemic. Approval of issuance, verification, and acceptance of COVID Certificates from Cabo Verde and recognition of COVID Certificates

 Reinforcement of the vaccination campaign in Santa Catarina of Santiago with the assembly of more than 6 mobile vaccination tents on Saturdays, in partnership with the Civil Protection, Red Cross and reinforcement with vaccination teams from other councils in the region.



According to data, as of the 24th of October, over 75% of the eligible population in five (5) municipalities had been completely vaccinated.

By the 24th of October, 202 954 (54.8%) people had been vaccinated with the two doses, 14 605 more people than in the previous week.

From the 28th of June to the 24th of October, 116 036 young people aged between 18 and 39 years had received the one (1) dose of the vaccine against COVID-19, this represents 53,2% of the estimated population in this age group for the current year, (data from Census 2010 by INE).
