





HIGHLIGHTS

- The COVID-19 vaccination campaign started in March, 2021 in accordance with the National Plan for the Introduction of Vaccination against COVID-19 published in the Official Bulletin No. 19, February 18, 2021;
- As of December 05, approximately 307 957 (83,2% of the target population) were vaccinated with the first dose of the vaccine against Covid-19 and 254357 (68,7%) of the people were vaccinated with the second dose;
- By December 05, 87,2% (229 415) of the general eligible population (≥ 18 years of age who
 do not belong to the risk groups defined in the PNIV against COVID-19) had been vaccinated
 with the first dose;
- As of December 05, the country had administered 562 314 (75,5%) of the vaccines received through the COVAX mechanism and donations from partner countries;
- On the 29th of November, the country received 30 000 doses of the AstraZeneca vaccine from Portugal.



As of December 05, **307 957 (83,2%)** people were vaccinated with the first dose, **1 170** more than in the previous week.

- Publication of Resolution No. 82/2021, which approved the requirement to present a valid negative RT-PCR or antigen test result, every fourteen days, or a COVID Vaccination Certificate, by public and private service providers that provide customer services or who have direct contact with the public, as well as those who share common spaces and means of transport with them, as a public health protection measure and to reinforce vaccination efforts, in view of the COVID-19 pandemic. https://covid19.cv/wp-content/uploads/2021/08/bo 23-08-2021 81.pdf

- Approval of the COVID-19 Certificate, as a document proving the low risk of its holder being an active COVID-19 patient and as a measure to facilitate free movement and the carrying out of activities in the context of the COVID-19 pandemic. Approval of issuance, verification, and acceptance of COVID Certificates from Cabo Verde and recognition of COVID Certificates issued by other countries or multilateral institutions. https://covid19.cv/wpcontent/uploads/2021/07/bo/30-07-2021/75.pdf
- Reinforcement of the vaccination campaign in Santa Catarina of Santiago with the assembly of more than 6 mobile vaccination tents on Saturdays, in partnership with the Civil Protection, Red Cross and reinforcement with vaccination teams from other councils in the region.



According to data, as of December 05, the municipalities of Santa Catarina, São Salvador do Mundo, Tarrafal, Sao Miguel and Boavista registered vaccination rates of completely vaccinated individuals below 50%, relative to the respective eligible population.

By December 05, **254 357 (68,7%)** people had been vaccinated with the two doses, 3 840 more people than in the previous week.

From the June 28 to December 05, **121 460** young people aged between 18 and 39 years had received the one (1) dose of the vaccine against COVID-19, this represents **55,7%** of the estimated population in this age group for the current year, (data from Census 2010 by INE).
